## ADMISSIONS POLICY

The intention of the North Toronto Christian School is to provide the best possible academic education within a Christian environment. To facilitate this objective, the admissions policy is:

- **Readiness** - A criteria for admission to any grade. General achievement should not be more than three months below grade placement. Exceptions will be made in unusual circumstances if lower achievement can be satisfactorily explained and we feel that our program can be helpful.
- **Age** - Junior kindergarten children should be four years of age, senior kindergarten children should be five years of age, and grade one children should be six years of age by December 31st of the year of admission.
- **Behaviour** - Students applying from other schools must have a deportment record or recommendation that is average or above average.
- **Attitude** - Children should have a general eagerness toward learning, commensurate with their age.
  - Children who have developed a contempt for the Christian way of life will not be enrolled.
  - Children above the grade four level should be attending the school by their own choice.
- **Parents** - Parents must sign the Parents' Agreement below before admission will be approved.

Because of the great demand for places in the elementary school in recent years, it should be understood that many families who may satisfy the above general standards will still not gain admission to the school the first year that they apply simply due to a lack of available space.

## PARENTS' AGREEMENT

1. We agree to accept the challenge to "train up a child in the way he should go" in the home so that our child will bring to the school a heritage of Christian culture..
2. We agree that if, for any reason, our child does not respond favourably to the school, we will withdraw the child without delay. We also agree that if in future years the child develops an antipathy towards learning and/or a contempt for the objectives of the school, that we will willingly withdraw the student at the school's request.
3. We agree to pay the tuition according to school policy. We understand that tuition for one year must be paid in full before the student may continue the next year.
4. We agree to invest authority in the school to discipline our child as necessary. We further agree that we will co-operate and discipline our child in the home as needed.
5. We agree to pay any assessment made to cover damage made by our child to school property.
6. We agree to permit our child to participate in all aspects of the school's program except as agreed to with the principal in advance.
